MBE / WBE: This contract will be awarded in compliance with Chapter 2-9 of the City Code (Minority-Owned and Women-Owned Business Enterprise Procurement Program). No subcontracting opportunities were identified; therefore, no goals were established for this solicitation.

This contract is for the purchase of 90 Taser International Model X26E tasers with holsters, cartridge holders, and additional cartridges. They will be issued to the Austin Police Department 110th Cadet Class with the balance kept in inventory as spares to be used as replacements for tasers sent in for repair. The taser is standard issue for all officers assigned to patrol. Currently the department has 654 tasers assigned to patrol officers. Training in the use of this equipment is included in the cadet class curriculum. Upon graduation, the cadets will be assigned to patrol sectors throughout the city. The availability of this less-lethal equipment is critical for the safety of the officers and residents.
