This contract will provide for residential foundation repair and replacement for three homes in the Holly Good Neighbor service area. The Holly Good Neighbor Program was created and funded by Austin Energy and is administered by the Neighborhood Housing and Community Development Department. The program provides minor house repair services to residents and property owners in the area immediately adjacent to the Holly Power Plant.
