The property and residence located at 2426 West Cardinal Loop is a part of the approved Airport Noise Mitigation Program. The purpose of the program is to reduce noise impacts and ensure land use compatibility within the airport vicinity.

The lot to be acquired is approximately an 8.62-acre tract, more or less, and improvements include 149,744 square feet apartment buildings with all appurtenant appliances and furnishings for the office, model unit and pool furniture; 1,400 square feet laundry and storage facilities; 1,745 square feet office and clubhouse. The fair market value of the property including improvements is \$7,900,000, as determined by independent appraisal. The owner has agreed to accept the City's offer. The City will relocate tenants according to the Uniform Relocation Assistance and Real Property Acquisition Policies Act of 1970, as amended.

Closing and moving costs are not to exceed \$70,000, and are a part of the final property settlement amount.
