<u>SUBJECT</u>: Authorize negotiation and execution of a five-year revenue generating contract with PLAYER'S CONCESSIONS (MBE/MH-100%), Austin, TX, for food and beverage concessions at Lions Municipal Golf Course for an estimated annual revenue amount of \$60,000, with two 24-month extension options for an estimated annual revenue amount of \$60,000, for a total estimated revenue amount of \$540,000.

AMOUNT & SOURCE OF FUNDING: Net estimated revenue of \$300,000 over the duration of the five-year contract and \$60,000 annually for each 24-month extension option. Revenues are included in the Fiscal Year 2004-2005 Operating Budget of the Parks and Recreation Department.

This contract is for the management and operation of a food and beverage concession that provides short-order food and beverages to the golfing patrons and visitors of Lions Municipal Golf Course. The Concessionaire will furnish and operate a food area at this golf course and provide staffing, management, equipment, janitorial services, and other functions consistent with an operation of this type for a golf course operation.

Player's Concessions hours of operation are from sunrise to sunset, seven days a week. The concession will serve a short order menu consisting of breakfast items, sandwiches, burgers, drinks, and snacks. An eating area available for customers will also be maintained by the Concessionaire. In addition, a beverage cart will be used to provide drinks for golfers on the course Friday through Sunday, as well as during golf tournaments. The Concessionaire will provide janitorial services for the designated area of the concession

Council requested a process change to include citizen input for Tennis and Golf Pro contracts. PARD and Purchasing worked together to develop a new procedure, which has been used on all PARD concession solicitations since August 2004. The citizen input process was used for the food and beverage concession RFP for Lions Municipal Golf Course.
