This amendment increases the amount of the legal contract with Bickerstaff, Heath, Smiley, Pollan, Kevar & McDaniel, L.L.P. to provide legal counsel concerning the possible acquisition of all or part of an 86 acre tract of land on Highway 71 East, Austin, Travis County, Texas owned by Airport Commercial Center, Ltd.

The Law Department originally contracted with this firm on March 14, 2005. Because the landowner is currently in a Chapter 11 bankruptcy proceeding, the transaction has become significantly more complex and requires more legal time and effort than originally anticipated. Additional payment authority of up to \$55,000 is necessary to pay anticipated fees through the end of the FY05, with a total contract amount not to exceed \$80,000.
