<u>SUBJECT</u>: Authorize the execution of a construction contract with STEWART-MATL, LTD., Austin, TX, for the Austin-Bergstrom International Airport Elevator and Escalator Improvements project in the amount of \$4,411,000 plus a \$441,100 contingency, for a total contract amount not to exceed \$4,852,100.

The Terminal project includes replacing four existing escalators, installing two additional down escalators, installing four new elevators, and upgrading two existing elevators as part of an ongoing effort to maintain a high quality international airport. The construction is anticipated to start in August 2005 and to continue in phases until April 2007. The project has been closely coordinated with the airlines and airport tenants.

This project will replace four existing escalators, install two additional down escalators, install four new elevators, and upgrade two existing elevators, to improve passenger access during peak loads. It will also provide vertical transportation for passengers when the Terminal is expanded in the future. The project work plan is to complete the installation of each new escalator before beginning replacement of the existing one on each side of the Baggage Claim Lobby. Most of the work will be performed after the terminal closes each evening.

Due to the potential for unknown subsurface conditions and utility conflicts when excavation begins for elevator and escalator pits, a 10% contingency in funding has been included to allow for the expeditious processing of any future change orders. The contract allows 450 calendar days for completion of this project.

Bid documents were distributed to 3 general contractors. Bids were opened on May 11, 2005. Stewart-Matl, LTD. submitted the lowest of 3 bids received:


