<u>SUBJECT</u>: Authorize execution of a construction contract with AARON CONCRETE CONTRACTORS, LP (MBE/MH 38.13%), Austin, TX, for the CMTA-BGA Street Reconstruction on Middle Fiskville Road from Koenig Lane to Highland Mall Boulevard and on Northcrest Boulevard from Crestland Drive to Prince Drive Projects, for a total contract amount not to exceed \$943.097.80.

AMOUNT & SOURCE OF FUNDING: Funding in the amount of \$934,592.80 is available in the Fiscal Year 2004-2005 Amended Capital Budget of the Public Works Department and funding in the amount of \$8,505 is available in the Fiscal Year 1995-1996 Capital Budget of the Austin Water Utility.

PURCHASING: Lower of two bids received.

MBE / WBE: 4.24% MBE and 52.84% WBE subcontractor participation.

The Work consists of street rehabilitation for both Middle Fiskville Road and Northcrest Boulevard. Approximately 1,875 linear feet of Middle Fiskville Road will be reconstructed, including full depth pavement reconstruction, mill and overlay of existing pavement, reconstruction of sidewalk ramps to meet ADA requirements, replacement of bus pads and replacement of portions of curb and gutter and some driveways. Northcrest Boulevard will include street rehabilitation of 1,325 linear feet of roadway with a similar scope of work as described for Middle Fiskville Road.

The contract allows 90 working days for completion of this project.

Bid documents were distributed to seven general contractors. Bids were opened on May 26, 2005. Aaron Concrete Contractors, LP submitted the lower of two bids received:

Aaron Concrete Contractors, LP, Austin, TX \$943,097.80 Capital Excavation Company, Austin, TX \$1,373,320.37

The contractor's choice of work methodology provides for five areas of subcontracting opportunities: hot-mix asphalt, construction photos, seeding and erosion control, valve and manhole adjustments and hauling.

Project specific subgoals stated in the solicitation were 3.25% African American; 8.19% Hispanic; 0.85% Native/Asian American, 6.84% WBE. Total participation estimated on base bid amount of \$943,097.80.




