This proposal is to change the name of a portion of North Hearsey Drive from the intersection of North Hearsey Drive and Cottonwood Street easterly to the intersection of North Hearsey Drive and South Hearsey Drive to Apple Orchard Lane in the Viewpoint at Williamson Creek Phase 1 due to possible emergency issues. Future development in this area also warrants a name change to this street. At the request of the City, an application to change the name was filed to enhance the ease of locating the property, which is an allowed reason for a street name change under Section 14-5-4 of the Code.

This right-of-way is located within the City of Austin's corporate limits and on City grids J16 and K16. A map of the area is attached. Individual house numbers will remain unchanged.

A public hearing is not required, as 100 percent of the property owners have agreed to this change.

Staff has determined this request to be consistent with the City regulations and recommends passage of the ordinance.

**AN ORDINANCE CHANGING THE STREET NAME OF A PORTION OF

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:**

**PART 1.** The street name of North Hearsey Drive from the intersection of North Hearsey Drive and Cottonwood Street east to the intersection of North Hearsey Drive and South Hearsey Drive is changed to Apple Orchard Lane as authorized by Subsection 14-5-4(4) of the Code.
