This proposal is to change the name of La Puente Cove to Kisoba Terrace in the Pioneer Crossing Phase A Section 3 Subdivision due to a 9-1-1 emergency issue. Duplicate addresses along La Puente Cove and La Puente Drive are causing confusion to delivery and service providers. At the request of the City an application to change the name was filed to enhance the ease of locating the property, which is an allowed reason for a street name change under Section 14-5-4 of the Code.

This right-of-way is located within the City of Austin's corporate limits and on City grid B17. A map of the area is attached. Individual house numbers will remain unchanged.

A public hearing is not required, as 100 percent of the property owners have agreed to this change.

Staff has determined this request to be consistent with the City regulations and recommends passage of the ordinance.

**PART 1.** The street name of La Puente Cove is changed to Kisoba Terrace as authorized by Subsections 14-5-4(2) and (4) of the Code.

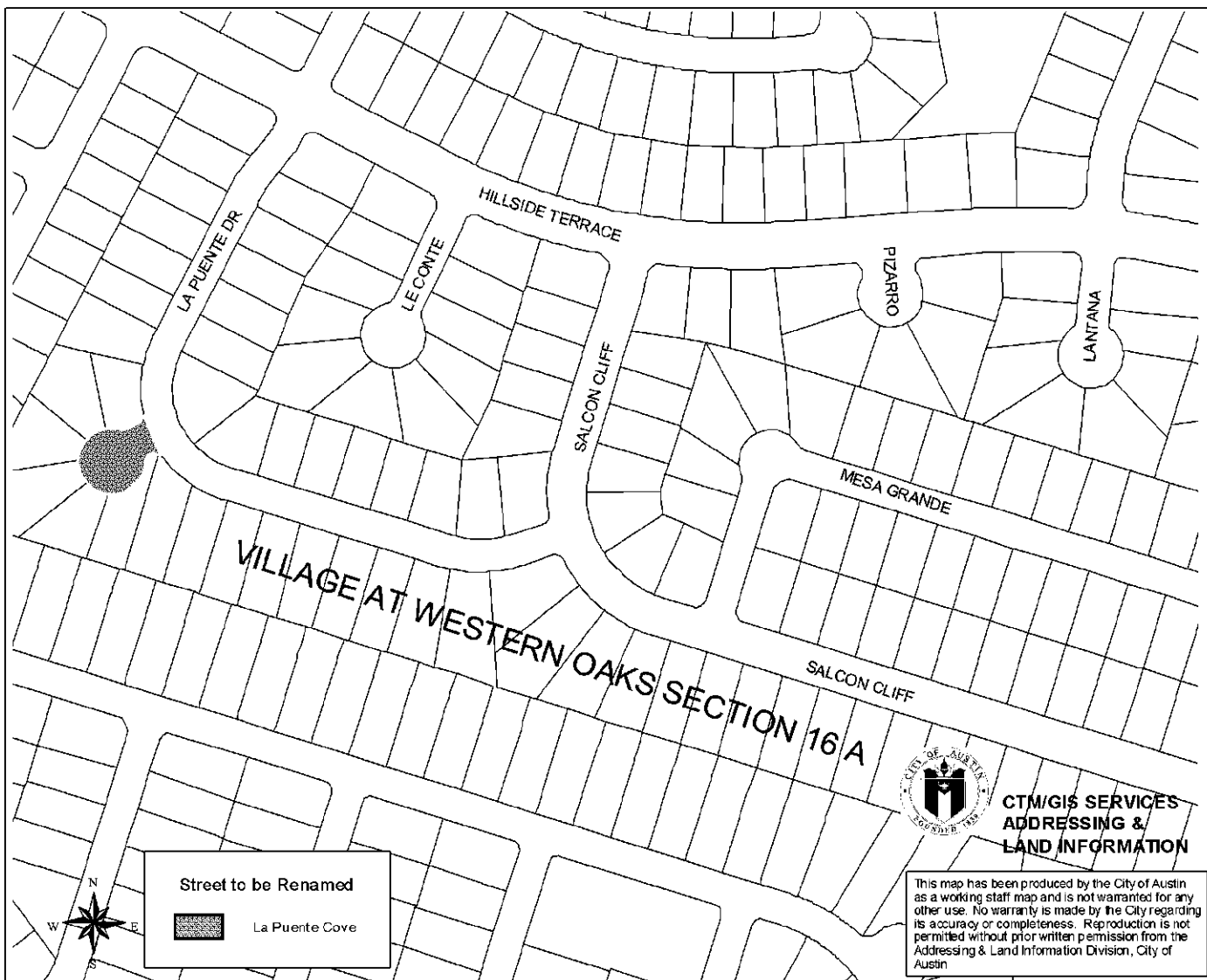
