<u>SUBJECT:</u> Authorize execution of change order # 2 to the construction contract with GUERRERO-MCDONALD & ASSOCIATES, AUSTIN, TX, (WBE) for Palmer Events Center, Miscellaneous Building Construction in the amount of \$1,970, for a total contract amount not to exceed \$833,102.

On November 3, 1998, Austin residents voted for propositions 11 and 12 to build a new Community (Palmer) Events Center and to allow for a lease with Art Centerstage to convert Palmer Auditorium into a Performing Arts Center in Town Lake Park. In July 1999, Council adopted the conceptual Town Lake Park Master Plan prepared by EDAW Inc. with significant community input from interested citizens and organizations during multiple public meetings and workshops. The Town Lake Park Site Development Permit Plan was adopted by Council in June 2000. The new Palmer Events Center opened on time and in budget on June 14, 2002.

The Palmer Events Center Miscellaneous Building Construction contract provides for several smaller work items not included in the original construction contract: additional security fencing in the garage and service yard, flag pole installation, bird control for portions of the shade roof, flashing on roof beams, new security window to the exhibit hall, adding floor finishes to the administrative stairwell, roof overflow drain piping containment, assisted-listening devices to comply with the Americans with Disabilities Act, baby changing stations, facility entrance sign, facility marquee, and a storage room at the parking garage. The contract identifies the construction duration of one hundred and eighty calendar days.

Change Order #2 provides for reconnection of lightning protection cabling, new hardware for relocated


