SUBJECT: Authorize execution of a 12-month supply agreement with AUSTIN BRAKE & CLUTCH SUPPLY, Austin, TX for heavy duty brake parts in an amount not to exceed \$100,000, with three 12-month extension options in an amount not to exceed \$100,000 per extension option, for a total agreement amount not to exceed \$300,000.

AMOUNT & SOURCE OF FUNDING: Funding in the amount of \$50,000 is available in the Fiscal Year 2003-2004 Approved Operating Budget of the Financial & Administrative Services Department, Fleet Fund. Funding for the remaining six months of the original contract period and extension options is contingent upon available funding in future budgets.

FISCAL NOTE: There is no unanticipated fiscal impact. A fiscal note is not required.
