SUBJECT: Authorize execution of Amendment No. 6 to the contract with AMIGOS LIBRARY SERVICES, Dallas, TX, to increase the contract for cataloging database membership services in an amount not to exceed \$6,774 and to increase the two remaining extension options in an amount not to exceed \$38,097 per extension option, for a total revised agreement amount not to exceed \$405,408.

AMOUNT & SOURCE OF FUNDING: Funding in the amount of \$19,473 is available in the Fiscal Year 2003-2004 Approved Operating Budget of the Library Department. Funding for the remaining eight months of the third extension option and the fourth extension option is contingent upon available funding in future budgets.

**FISCAL NOTE:** There is no unanticipated fiscal impact. A fiscal note is not required.

MBE / WBE: The original contract was awarded in compliance with Chapter 2-9 of the City Code (Minority-Owned and Women-Owned Business Enterprise Procurement Program). No subcontracting opportunities were identified; therefore, no goals were established for the contract.

Amigos Library Services provides cataloging services for the Austin Public Library, including the Austin History Center, the John Henry Faulk Central Library and the twenty branch libraries. Librarians worldwide use Amigos' OCLC (Online Computer Library Center) system to share cataloging via the Dewey Decimal System. This is a complex classification system by which librarians categorize all material into subject areas. Each title is cataloged once by a librarian, and the information is put into the OCLC database for all member libraries to download into their online catalogs. This shared cataloging saves the Library staff from individually classifying the many thousands of titles received annually.

This Amendment No. 6 will increase the current year contract amount by \$6,774 for increased cataloging services. At the same time, the Library is requesting an increase of \$38,097 for each of the two remaining extension options (3rd and 4th), which includes the additional features (Dewey Decimal-\$500 and Promptcat-\$23,000), \$12,957 from previous increased usage and \$1,640 for anticipated increased usage as indicated by the historical data of the contract.
