**SUBJECT:** Approve a resolution authorizing the filing of eminent domain proceedings for the Austin Clean Water Program - Upper Tannehill - Airport and IH 35 portion to acquire a 245 square foot permanent wastewater line easement out of a 0.535 acre tract of land, more or less, being Lots 1, 2 and a portion of Lot 3, F. Haster Subdivision, and the east 50' of Lot 1, Block O, Ridgetop, a subdivision in Travis County, in the amount of \$772. The owner of the property sought to be condemned is MOHAMMAD H. GHARBI.

The design plans for the Upper Tannehill – Airport and IH 35 portion of the Austin Clean Water Program require acquisition of a permanent wastewater line easement across land located at 1014 East 53rd Street.

The City of Austin has attempted to purchase the permanent wastewater line easement from the landowner, however, the parties have been unable to agree on an appropriate price. The City of Austin offered \$772 and Mohammad H. Gharbi demanded \$6,125. The Law Department is requesting authorization to file a lawsuit in eminent domain on behalf of the City of Austin.
