SUBJECT: Approve a resolution to authorize the fee simple acquisition of 5.00 acres out of the Noel M. Bain Survey, Abstract No. 61, Travis County, TX, locally known as 11502-B McAngus, Del Valle, TX, from Eloisa Saldana for the Airport Noise Mitigation Program, in the amount of \$110,000 for the land and improvements and \$30,931.47 relocation benefits, plus closing costs and moving related expenses in the amount of \$10,000, for an amount not to exceed \$150,931.47

AMOUNT & SOURCE OF FUNDING: Funding in the amount of \$150,931.47 is available in Fiscal Year 2003-2004 Capital Budget of the Department of Aviation using airport funds and available Federal Aviation Administration (FAA) Grants.

PRIOR COUNCIL ACTION: 09/09/99 - Federal Aviation Regulations (FAR) Noise Study; 08/23/01 - Consultant Selection for Noise Mitigation Program.

BOARD AND COMMISSION ACTION: N/A

The property and residence located at 11502-B McAngus Road is a part of the approved Airport Noise Mitigation Program. The purpose of the program is to reduce noise impacts and ensure land use compatibility within the airport vicinity.

The lot to be acquired is approximately 5.00 acre tract and improvements include a single family residence, 3 metal sheds, and fencing. The fair market value of the property including improvements is \$110,000, as determined by independent appraisal. The owner has agreed to accept the City's offer and is eligible for relocation expenses estimated to be \$30,931.47. The City will relocate any tenants according to the Uniform Relocation Assistance and Real Property Acquisition Policies Act of 1970, as amended.

Closing and moving costs are not to exceed \$10,000, and are a part of the final property settlement amount.


