On September 26, 2002, Council approved an interlocal agreement with Austin Community College to provide software training for small business owners in an amount not to exceed \$16,370. The original one-year agreement term was intended to become effective when all parties signed the agreement. Due to an administrative oversight, the interlocal agreement was not signed until April 21, 2003. However, Austin Community College began providing classes on January 28, 2003, and the City made payments.

This amendment will modify and extend the original term of the interlocal agreement with Austin Community College so the term is effective January 28, 2003, through September 30, 2004. Austin Community College will continue to provide a series of computer and software classes to small business owners. The curriculum of classes was not completed by the one-year expiration set in the original agreement, so this extension for time is needed to allow the curriculum to be completed. Funding in the amount of \$7,010 remains available from the original agreement, which will be used to fund the remaining services.

The classes offered through this agreement assist small business owners to identify new business opportunities and to stay current on new and improved technologies so they can remain competitive. This interlocal agreement with Austin Community College provides professional instruction in basic computer skills and commercial software such as MS Word, MS Excel, MS Publisher, MS Project, and QuickBooks. The series has included classes delivered in Spanish, as well as QuickBooks classes tailored to specific industries such as Construction and Retail sales.
