This purchase will provide influenza vaccine for the upcoming 2004/2005 flu seasons. The vaccine will be administered at the clinics operated by the Community Care Services Department (CCSD), and the Austin-Travis County Health and Human Services Department (A/TCHHSD).

The vaccine will be purchased through the state contract (State Term Contract 269-N3) and must be ordered by May 15, 2004, for the vendor to guarantee delivery by September 30, 2004. This will allow CCSD and A/TCHHSD flu clinics to immunize their high-risk patients early in the flu season. Patients receiving the flu vaccine will include the elderly, homeless, immuno-depressed and low-income children. Under the City's Wellness program, HealthPLUS, flu immunizations will be made available to City employees at various City work sites in Fall 2004.

Aventis is under contract with the Texas Building and Procurement Commission (TBPC) to supply influenza vaccine statewide as a result of a competitive bidding process through TBPC.
