SUBJECT: Authorize execution of 12-month supply agreement with AMERICAN INDUSTRIAL PRECAST PRODUCTS, Seguin, TX for precast concrete manholes in an amount not to exceed \$68,595, with four 12-month extension options in an amount not to exceed \$68,595, for a total agreement amount not to exceed \$342,975.

AMOUNT & SOURCE OF FUNDING: Funding in the amount of \$28,581.25 is available in Fiscal Year 2003-2004 Amended Operating Budget of the Electric Utility Department. Funding for the remaining seven months of the original contract period and extension options is contingent upon available funding in future budgets.
