SUBJECT: Approve resolution to authorize the acquisition of a wastewater easement comprised of 3,695 square feet of land, a wastewater easement comprised of 1,740 square feet of land, a temporary working space easement comprised of 3,960 square feet of land, an access easement comprised of 2,333 square feet of land, a lateral support (slope) easement comprised of 1,042 square feet of land, and a wastewater line easement for subterranean tunnel comprised of 1,485 square feet of land out of a portion of the George W. Spear League, Survey No. 7, in Travis County, TX, located at 1101 W. 31st Street, from Fred C. Myers and Jennifer Staub Myers in the amount not to exceed \$58,246 for the Austin Clean Water Program: Shoal Creek Wastewater Improvements/29th to 34th Street (Tunnel) Project.

The City of Austin is upgrading its wastewater collection system as mandated by the U.S. Environmental Protection Agency's Administrative Order, received April 29, 1999, requiring the City to eliminate Sanitary Sewer Overflows from the wastewater collection system.

In response to the U.S. Environmental Protection Agency's Administrative Order, the City of Austin has assembled the Austin Clean Water Program to plan, design, and construct sustainable wastewater collection system improvements that will result in a collection system free from Sanitary Sewer Overflows.

The design plans for the Austin Clean Water Program's Shoal Creek Wastewater Improvements/29th to 34th St. (Tunnel) Project require the acquisition of a wastewater easement comprised of 3,695 square-feet of land, a wastewater easement comprised of 1,740 square-feet of land, a temporary working space easement comprised of 3,960 square-feet of land, an access easement comprised of 2,333 square-feet of land, a lateral support (slope) easement comprised of 1,042 square-feet of land, and a wastewater line easement for subterranean tunnel easement comprised of 1,485 square-feet of land across property located at 1101 W. 31st St., Austin, TX.

An independent third-party appraisal has established the combined fair-market value of the proposed easements at \$58,246. The owners have agreed to accept the City of Austin's offer of \$58,246 for the wastewater easement comprised of 3,695 square-feet of land, a wastewater easement comprised of 1,740 square-feet of land, a temporary working space easement comprised of 3,960 square-feet of land, an access easement comprised of 2,333 square-feet of land, a lateral support (slope) easement comprised of

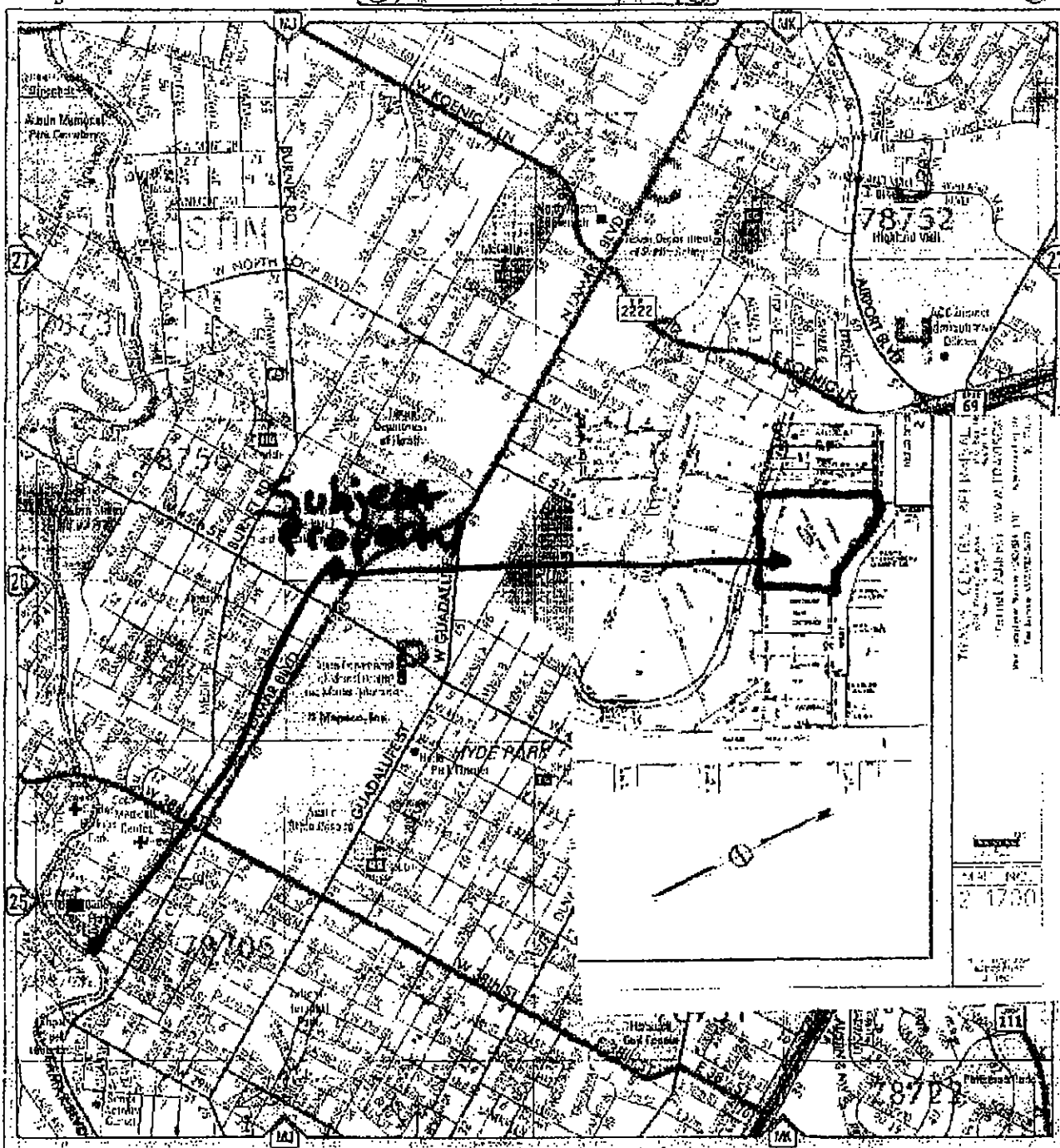
