SUBJECT: Authorize execution of a construction contract with CAPITAL EXCAVATION COMPANY, Austin, TX, for (1) street reconstruction of East William Cannon Drive from east of the intersection of South Pleasant Valley Road / East William Cannon Drive to east of the intersection of East William Cannon Drive / Running Water Drive and (2) the construction of the South Austin Soccer Complex east of Onion Creek and north of East William Cannon Drive in the amount of \$5,887,527.68 plus a \$294,376.38 contingency, for a total contract amount not to exceed \$6,181,904.06.

<u>AMOUNT & SOURCE OF FUNDING:</u> Funding in the amount of \$5,355,625.24 is available in the Fiscal Year 2002-2003 Amended Capital Budget for the Transportation, Planning, and Sustainability Department; \$826,278.82 is available in the Fiscal Year 2002-2003 Amended Capital Budget of the Parks and Recreation Department, with \$420,000 available from the Austin Men's Soccer Association private contribution.

The purpose of this project is to replace the existing two-lane roadway with a six-lane divided street, three lanes each direction. The street reconstruction project begins just east of the intersection of South Pleasant Valley Road / East William Cannon Drive and extends to the area just east of the intersection of East William Cannon Drive. The roadwork portion of the project consists of constructing a six-lane reinforced concrete pavement, a concrete median, curbs and gutters, sidewalks, concrete rip-rap slope protection, ADA ramps and pavement markings, storm sewer system, water quality ponds, automatic barricade gate system, channel excavation, and stream bank restoration.

The Soccer Complex project involves the construction of parking and infrastructure to support a 9-field soccer complex. The Parks and Recreation Department will build the fields with in-house forces. The infrastructure will include curb and gutter, sidewalk, signing, pavement markings, storm sewer, water line, wastewater line, bike racks, landscape, and turf. The parking lot improvements were included in this contract because the work is similar to the William Cannon paving work and a cost saving can be achieved.

Due to the potential for unknown subsurface conditions and utility conflicts when working in the right-ofway, a 5% contingency in funding has been included to allow for the expeditious processing of any future change orders. The contract allows 580 calendar days for completion of this project.


