SUBJECT: Authorize execution of a construction contract with TEXAS ROAD AND UTILITIES, INC., (WBE/FR 72.40 %), Buda, TX, for the Austin Clean Water Program - West Gate Neighborhood Wastewater Collection System Improvement Project in the amount of \$1,871,791.50 plus a \$187,179 contingency, for a total contract amount not to exceed \$2,058,970.50.

AMOUNT & SOURCE OF FUNDING: Funding in the amount of \$2,058,970.65 is included in the Fiscal Year 2003-2004 Capital Budget of the Austin Water Utility.

PURCHASING: Lowest bid of four bids received.

This construction contract will provide for wastewater improvements within a mostly residential area generally bound to the west by Sunset Trail, to the east by Roundup Trail, to the north by Western Trails Boulevard, and to the south by Jones Road. The improvements will replace aging and deteriorated wastewater facilities and eliminate the repeat wastewater overflows currently occurring in this area. This project is part of the Austin Water Utility's Austin Clean Water Program (ACWP), which was developed to respond to the requirements of the Environmental Protection Agency's Administrative Order regarding Sanitary Sewer Overflows.

The proposed improvements include the installation of approximately 153 feet of 18-inch wastewater line by open-cut methods; 2,365 linear feet of 15-inch wastewater line by open-cut methods; 2,014 feet of 12-inch wastewater line by open-cut methods; and 3,101 feet of 8-inch wastewater line with 18" steel casing pipe by open-cut methods. Also included is the reconnection of 67 residential services within the right-of-way, relaying approximately 2,080 feet of private wastewater line, associated asphalt trench repair and other associated repairs/replacements.

Due to the potential for unknown subsurface conditions and utility conflicts when working underground, a 10% contingency in funding has been included to allow for the expeditious processing of any future change orders. The contract allows 240 working days for final completion of this project.

Bid documents were distributed to 14 general contractors. Bids were opened on April 22, 2004. The Texas Road & Utilities, Inc. submitted the lowest of 4 bids received:


