ORDINANCE NO.

AN ORDINANCE AUTHORIZING THE WAIVER, REIMBURSEMENT AND PAYMENT OF CERTAIN FEES AND THE WAIVER OF THE SIGNATURE REQUIREMENT CONTAINED IN SECTIONS 14-8-16 AND 14-8-17 OF THE CITY CODE, IN CONNECTION WITH THE AUSTIN EASTSIDE STORY FOUNDATION PRE-JUNETEENTH PARADE TO BE HELD ON JUNE 18, 2004.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

PART 1. The Council waives the following fees in connection with the Austin Eastside Story Foundation Pre-Juneteenth Parade to be held on June 18, 2004.

Security Deposit	\$ 50.00
Sound Amplification Fee	\$ 22.00

PART 2. The Council authorizes reimbursement of the following fees for the Austin Eastside Story Foundation Pre-Juneteenth Parade:

Application Fee	\$ 100.00
Permit Fee	\$ 50.00

PART 3. The Council authorizes payment of the following expenses in connection with the Austin Eastside Story Foundation Pre-Juneteenth Parade:

Police Officers – Austin Police Department	\$ 5,100.20
Barricades – Transportation Planning & Sustainability Department	\$ 2,800.00

PART 4. The Council waives the signature requirement contained in Code Sections 14-8-16 and 14-8-17 of the Code in connection with the Austin Eastside Story Foundation Pre-Juneteenth Parade.

SUBJECT: Pre-Juneteenth Parade

This item on the June 10, 2004 Council Agenda falls under Chapter 14-8 of the City Code. Under these provisions, the following fees would be applicable to the June 18, 2004, Austin Eastside Story Foundation Pre-Juneteenth Parade:

\$ 100.00 Application Fee (to be reimbursed)
\$ 50.00 Permit Fee (to be reimbursed)
\$ 22.00 Sound Amplification Fee
\$ 172.00 Total waived/reimbursed fees

In addition, this item authorizes payment for the following expenses associated with the Pre-Juneteenth Parade:

\$ 2,800.00 TPSD-Barricades
\$ 5,100.20 APD-Police Officers
\$ 7,900.20 Total authorized payments

In summary, the cost impact of this item is \$8,072.20.

Although budgeted revenue for fees is based upon historical data and not necessarily upon specific events, the waiver of these fees reduces potential revenues that could be realized.
