SUBJECT: Authorize execution of a 12-month supply agreement with INDUSTRIAL DISPOSAL SUPPLY, San Antonio, TX, for the purchase of captive repair parts for TYMCO street sweepers in an amount not to exceed \$100,000, with two 12-month extension options in an amount not to exceed \$100,000 per extension option, for a total agreement amount not to exceed \$300,000.

AMOUNT & SOURCE OF FUNDING: Funding in the amount of \$33,333 is available in the 2003-2004 Approved Operating Budget for the Fleet Maintenance Fund of the Finance and Administrative Services Department. Funding for the remaining eight months of the original contract period and extension options is contingent upon available funding in future budgets.

FISCAL NOTE: There is no unanticipated fiscal impact. A fiscal note is not required.

<u>MBE / WBE:</u> This contract will be awarded in compliance with Chapter 2-9 of the City Code (Minority-Owned and Women-Owned Business Enterprise Procurement Program). No subcontracting opportunities were identified, therefore, no goals were established for this solicitation.

This supply agreement is for captive repair parts for the City's fleet of street sweepers manufactured by TYMCO. These repair parts will be purchased on an as needed basis for general routine maintenance and repairs. There are approximately 11 TYMCO street sweepers in the City's current fleet. This contract is necessary to support the automotive and equipment fleet service centers by providing them with a reliable and continuous source of supply.

The contract amount is estimated at \$100,000 based on the City's expenditures for the past three years.

PRICE ANALYSIS

- c. The current pricing represents approximately 8% increase to the last contract awarded in March 2001. This is due to the increase in steel prices.
