<u>SUBJECT:</u> Authorize execution of three 12-month supply agreements with FREIGHTLINER OF AUSTIN, Austin, TX, PERFORMANCE INDUSTRIAL POWER, Buda, TX, and LONGHORN INTERNATIONAL TRUCKS LTD, Austin, TX, for the purchase of original equipment manufacturer parts and services for medium and heavy duty diesel engines and transmissions in amounts not to exceed \$185,000, \$100,000 and \$200,000 respectively, with three 12-month extension options in amounts not to exceed \$185,000, \$100,000 and \$200,000 respectively, for total agreement amounts not to exceed \$740,000, \$400,000 and \$800,000 respectively.

AMOUNT & SOURCE OF FUNDING: Funding in the amount of \$161,667 is available in the Fiscal Year 2003-2004 Approved Operating Budget for the Fleet Maintenance Fund of the Finance and Administrative Services Department. Funding for the remaining eight months of the original contract period and extension options is contingent upon available funding in future budgets.

FISCAL NOTE: There is no unanticipated fiscal impact. A fiscal note is not required.
