<u>SUBJECT</u>: Approve an ordinance amending City Code Section 12-4-42 by adding Old Bee Caves Road from William Cannon Drive (West) to Travis County Line (2,075 feet from SH 71) to the list of streets having a maximum speed limit of 40 miles per hour.

ORDINANCE NO.

AN ORDINANCE AMENDING SECTION 12-4-42 OF THE CITY CODE TO ADD A PORTION OF BEE CAVES ROAD FROM WILLIAM CANNON DRIVE (WEST) TO THE TRAVIS COUNTY LINE (2,075 FEET FROM STATE HIGHWAY 71) TO THE LIST OF STREETS HAVING A MAXIMUM SPEED LIMIT OF 40 MILES PER HOUR.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

PART 1. Section 12-4-42 (*Maximum Speed Limit of 40 Miles Per Hour*) of the City Code is amended to add:

Old Bee Caves Road from William Cannon Drive (West) to the Travis County Line (2,075 feet from State Highway 71).

PART 2. The amendments made in this ordinance shall be incorporated in alphabetical order and the existing subsections renumbered accordingly.

PART 3. This ordinance takes effect on ______, 2004.
