<u>SUBJECT</u>: Approve a resolution to authorize the acquisition of (1) a temporary working space easement comprised of 44,953 square-feet of land; (2) a temporary staging area and material storage site easement comprised of 7,586 square-feet of land, and (3) a temporary ingress and egress easement comprised of 15,747 square-feet of land, out of a portion of the Outlot 49, Division "B", City of Austin, in Travis County, TX, located at 0 East Martin Luther King, Jr. Boulevard, from BLT PROPERTIES, LTD. in the amount not to exceed \$127,600 for the Austin Clean Water Program.

The City of Austin is upgrading its wastewater collection system as mandated by the U.S. Environmental Protection Agency's Administrative Order, received April 29, 1999, requiring the City to eliminate Sanitary Sewer Overflows from the wastewater collection system.

In response to the U.S. Environmental Protection Agency's Administrative Order, the City of Austin has assembled the Austin Clean Water Program to plan, design, and construct sustainable wastewater collection system improvements that will result in a collection system free from Sanitary Sewer Overflows.

The design plans for the Austin Clean Water Program's Moss-Roundtree/Pannell Project require the acquisition of a temporary work space easement comprised of 44,953 square-feet of land, a temporary staging area and material site easement comprised of 7,586 square-feet of land, and a temporary ingress and egress easement comprised of 15,747 square-feet of land across property located at 0 ML King Jr. Blvd. East., Austin from BLT PROPERTIES, LTD. There was a difference of opinion as to the fair market value of the easements. The City's appraiser initially determined the value to be \$94,834, but when BLT Properties, LTD., provided additional information, the City's appraiser accept the counter-offer value of \$127,600.
