The Firefighters' and Police Officers' Civil Service Commission performs important functions with respect to the hiring, promotion, discipline, and removal of Fire Fighters and Police Officers pursuant to Chapter 143 of the Local Government Code.

The following individuals are currently serving staggered three (3) year terms on the Commission: Mr. Gerald F. Henderson, Dr. Judith A. Loredo, Rev. Fred L. Daughtry.

Appointments: The three (3) members of the Firefighters' and Police Officers' Civil Service Commission are appointed by the City Manager, and confirmed by the City Council under the provisions of Chapter 143 of the Local Government Code.

Mr. Henderson's current appointment to the Commission will expire on May 6, 2004.
