**SUBJECT:** Authorize execution of a contract through the State of Texas, Texas Building and Procurement Commission, with HAWORTH INCORPORATED, Austin, TX, and its authorized distributor FURNITURE MARKETING GROUP, Austin, TX, for the purchase and installation of modular office systems for built-in cubicle arrangements including wall panels, desk tops, and cabinets in an amount not to exceed \$1,300,961.77.

AMOUNT & SOURCE OF FUNDING: Funding in the amount of \$673,000 is available in the Fiscal Year 2003-2004 Approved Operating Budget of the Watershed Protection and Development Review Department, Drainage Utility Fund. Funding in the amount of \$627,961.77 is available in the Fiscal Year 2003-2004 Approved Operating Budget of the Financial Services Department, One Texas Center Fund.

This contract will provide for modular panel walls and modular office furniture to furnish 299 offices for the relocation of the Watershed Protection and Development Review; Transportation, Planning, and Sustainability; and Human Resources Departments to One Texas Center. These departments will be relocating from leased facilities located at Two Commodore Plaza, 206 East 9th Street, and 1011 San Jacinto Street to the City-owned One Texas Center. The space at One Texas Center has 59,237 square feet and includes approximately 299 modular offices and workstations with conference/training rooms, records storage areas and laboratory area. The lease space being vacated is approximately 63,223 square feet. The existing modular panels and freestanding furniture currently used by the departments is over 20 years old, bulkier than the new space will accommodate, providing inadequate office areas to accommodate the staff in One Texas Center building space.

Currently, Watershed Protection and Development Review Department and Human Resources Departments are located at Two Commodore Plaza; Transportation, Planning & Sustainability is located at San Jacinto. The relocation will provide significant rent savings. The rent at Two Commodore is \$21.62 per square foot (excluding parking costs) per year; San Jacinto is \$29.00 per square foot; and One Texas Center is \$16.17 per square foot, resulting in savings in excess of \$500,000 per year. At this rate, the renovation and relocation project has a pay back period of approximately 7 years.

Office chairs, keyboard trays and moveable wall panels/doors are not available under the State contract.
