

## Purchasing Supply Agreement CITY OF AUSTIN RECOMMENDATION FOR COUNCIL ACTION

<u>SUBJECT:</u> Authorize execution of a 12-month supply agreement with GENERAL ELECTRIC SUPPLY, Austin, TX, for street light lamps in an amount not to exceed \$78,305.70, with two 12-month extension options in an amount not to exceed \$78,305.70 per extension option, for a total agreement amount not to exceed \$234,917.10.

<u>AMOUNT & SOURCE OF FUNDING</u>: Funding in the amount of S26,101.92 is available in the Fiscal Year 2003-2004 Amended Operating Budget of the Electric Utility Department. Funding for the remaining eight months of the original contract period and extension options is contingent upon available funding in future budgets.

FISCAL NOTE: There is no unanticipated fiscal impact. A fiscal note is not required.

<u>MBE / WBE:</u> This contract will be awarded in compliance with Chapter 2-9 of the City Code (Minority-Owned and Women-Owned Business Enterprise Procurement Program). No subcontracting opportunities were identified; therefore, no goals were established for this solicitation.

This contract will establish a 12-month supply agreement for street light lamps. This agreement will provide ten types of mercury vapor, high-pressure sodium, incandescent, and metal halide lamps for warehouse stock replenishment. Austin Energy will use this agreement to purchase lamps used for security and street lighting purposes. The street light lamps provide lighting in the Austin Energy service area (Hays, Travis & Williamson counties) on Austin streets, highways, and in residential areas and alleys.
