

The design plans for the Upper Tannehill-Broadmoor and Cameron portion of the Austin Clean Water Program require acquisition of a permanent wastewater line easement on land located at 1309 Broadmoor Drive.

The City of Austin has attempted to purchase the permanent wastewater line easement from the landowner by offering \$1,944; the landowner countered with \$8,500. The Law Department is requesting authorization to file a lawsuit in eminent domain on behalf of the City of Austin.
