Austin Energy intends to provide on-site electric power, chilled water for cooling, and steam/hot water for heating for the new Seton Children's Hospital being constructed on the Mueller redevelopment site by constructing, operating, and owning a Cooling-Heating-Power total energy system ("CHP System") to be located on land leased from Seton, adjacent to the Children's Hospital. Catellus will be supplying the underground utility piping necessary for Austin Energy to provide district cooling services to future customers located at the Mueller airport redevelopment site.

This CHP System is of sufficient capacity and efficiency to allow cooling services to be extended to other customers located nearby the Children's Hospital. This piping allows for these cooling services to be extended to future customers in a manner very similar to the AE downtown district cooling system. The AE chilled water piping will be installed as a part of other underground utilities that Catellus is installing at the site. This will provide for lower costs and avoid construction delays, and will avoid having to excavate new streets for future extensions of the chilled water distribution system.
