The City of Austin and Catellus sponsored a month-long input program to solicit potential names for the redevelopment of Robert Mueller Municipal Airport (RMMA). To announce the input program, ads were placed in the Austin American-Statesman, Austin Chronicle, NOKOA, the Villager and La Prensa.

In addition to paid media, the City and Catellus publicized the opportunity to submit name suggestions through the various neighborhood list serves and newsletters and one the redevelopment web site. A press release was drafted and distributed to local media for coverage. The Austin American Statesman, KXAN and KVUE did stories about the naming process.

At the end of the one-month input program, members of the public had submitted 715 names. A panel consisting of five members was created to evaluate the names and make a recommendation to the City. The group was made up of two City of Austin representatives, two Catellus representatives and a member of the Mueller Plan Implementation Advisory Commission.

The 715 names submitted included many creative, humorous and intriguing names. The majority, however, had "Mueller" in the title. There appeared to be an overwhelming sentiment to recognize the association with the Robert Mueller family. Mueller has such a strong name recognition in the general vicinity of Austin that there is instantly identification of place. It also evokes the thought of the old airport, even if the thought is mostly subliminal. There is also a tendency in naming projects to use the underlying subdivision name in the ensuing project names. Both these reasons argued for a name that was simple, yet nostalgic.

Robert Mueller (pronounced "Miller") was born June 15, 1881, in Travis County to Mr. and Mrs. J.C. Mueller. He attended school in Austin. His first job was as a clerk in a general merchandising store. Mueller was a leader in the community and was elected commissioner in 1926 to the first City Council under the newly adopted City Manager charter. He had the largest vote, but declined election as Mayor in deference to his senior colleague, P. W. McFadden. After several months in office, he died on January 12, 1927. In April 1930, the City Council named Austin's first municipal airport the Robert Mueller Municipal Airport in his honor.

After reviewing all the names and discussing all the possibilities, we focused on one name that was both simple and nostalgic. So that there can be names such as The Retreat at Mueller, Mueller Heights, Mueller Midtown or Midtown at Mueller.
