The applicant, Sally Matsumae, owner of Asahi Imports, requests a waiver from the minimum distance requirement of 300 feet in Section 4-9-4(A) of the City Code because the business intends to sell alcoholic beverages at a grocery store that is located 175 feet from a public school, Lamar Middle School, at 6201 Wynona Avenue.

Section 4-9-5 allows the City Council to waive the 300-foot distance requirement if it determines that enforcement of the distance requirement in a particular instance:

- (1) is not in the best interest of the public;
- (2) constitutes waste or the inefficient use of land or other resources;
- (3) creates an undue hardship on an applicant;
- (4) does not serve its intended purpose,
- (5) is not effective or necessary; or
- (6) for any other reason the council, after consideration of the health, safety, and welfare of the public and the equities of the situation, determines is in the best interest of the community.

Section 4-9-5(B) provides that the City Council may consider a written consent to the waiver of the 300-foot distance requirement provided by each church, public school, public hospital, day-care center or child-care facility within 300 feet of the proposed place of business to be sufficient justification for the waiver. 
REQUEST:

The applicant, Sally Matsumae, requests a waiver from the minimum distance requirement of 300 feet in Section 4-9-4(A) of the Austin City Code in order to sell beer and wine at a proposed grocery store. The grocery store is located at 6105 Burnet Road, which is 175 feet from a public school, Lamar Middle School, at 6201 Wynona Avenue.

Section 4-9-5(A) allows the City Council to waive the 300-foot distance requirement if they determine that enforcement of the distance requirement in a particular instance:

- (1) is not in the best interest of the public;
- (2) constitutes waste or the inefficient use of land or other resources;
- (3) creates an undue hardship on an applicant
- (4) does not serve its intended purpose
- (5) is not effective or necessary; or
- (6) for any other reason the City Council, after consideration of the health, safety, and welfare of the public and the equities of the situation, determines is in the best interest of the community.
