This request is to accept equipment or funds for services totaling approximately \$756,597, from the

Office for Domestic Preparedness, U.S. Department of Homeland Security, State Homeland Security Program.

Of the total amount, \$136,198 will fund a Law Enforcement Terrorism Prevention Program (LETPP), the

goal of which is to provide the Austin Police Department and other City Departments, with enhanced capabilities for detecting, deterring, disrupting, and preventing acts of terrorism. Eligible categories for the LETPP include: information sharing to preempt terrorist attacks, target hardening to reduce vulnerability of selected high value targets, intervention activities to interdict terrorists before they can execute a threat, and interoperable communications. LETPP funds may also be used to pay for exercise expenses and overtime costs associated with exercises, planning for threat assessments, strategy and plan development, and training for attendance at office of Domestic Preparedness approved training.

The remaining funds totaling \$620,399, will be used to purchase equipment to assist the Fire, Emergency Medical Services, Police, Emergency Management and other appropriate City of Austin Departments should they be called upon to respond to a terrorist incident. Eligible expenditures include equipment in the following categories: personal protection, explosive device mitigation and remediation, interoperable communications, physical security enhancement, terrorism incident prevention, and terrorism-related incident response vehicles. Again, these funds may also be used to pay for exercise expenses and overtime costs associated with exercises, planning for threat assessments, strategy and plan development, and training for attendance at office of Domestic Preparedness approved training.

The equipment to be purchased will be specified by the City of Austin, and will be purchased through either a Federal Prime Vendor Contract or through individually selected vendors. There is no match required by the City of Austin. When purchasing from individually selected vendors for such items as specialized communications equipment, City funds will be used. All such expenditures will however be reimbursed by the Domestic Preparedness Equipment Grant. This purchase and reimbursement process requires the Budget Amendment being requested.

As a note, regional allocations of Fiscal Year 2004 Domestic Preparedness grant funds, have yet to be determined. These decisions should be finalized before the end of the year and may then require a contract amendment or an additional contract agreement to be approved by the City Council.

Goal: To acquire and place in service special equipment for use locally by Austin Police, Fire, EMS, Emergency Management and other response personnel in the event of a terrorist incident involving chemical, nuclear, or biological weapons.

Objectives:

- To research existing or emerging devices and equipment that best meet the needs of Austin.
- To have selected devices and equipment purchased and delivered to the City of Austin.
- To place items in service with appropriate departments or agencies.

Devices and equipment will be selected and submitted for purchase prior to November, 2005.

ORDINANCE NO.

AN ORDINANCE AUTHORIZING THE ACCEPTANCE OF GRANT FUNDS AND AMENDING THE FISCAL YEAR 2003-2004 MANAGEMENT SERVICES OPERATING BUDGET OF ORDINANCE NO. 030909-01 TO APPROPRIATE FUNDS; AND DECLARING AN EMERGENCY.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

- **PART 1.** The Council authorizes the acceptance of \$756,597 in grant funds from the United States Department of Homeland Security Domestic Preparedness Grant to enhance local first response capabilities for terrorist incidents.
- **PART 2.** The Council amends the Fiscal Year 2003-2004 Management Services Operating Budget of Ordinance No. 030909-01 to appropriate \$756,597 to the Office of Emergency Management Special Revenue Fund.
- **PART 3.** The Council finds that the need to amend the budget constitutes an emergency, a grave public necessity, and an unusual and unforeseen condition that could not, by reasonable diligence, have been included in the original budget for the current fiscal year. Because of this emergency, this ordinance takes effect immediately on its passage for the immediate preservation of the public peace, health, and safety.
