The Walsh Tract Lift Station was designed in 1947 and is located at 1502 Scenic Drive adjacent to City of Austin parkland and serves the areas around Lake Austin. The facility has experienced several mechanical and electrical problems including sanitary sewer overflows downstream and upstream of the lift station. The project will downsize and rehabilitate the Walsh Tract Lift Station to be in compliance with the Texas Commission and Environmental Quality (TCEQ) and current Austin Water Utility standards. This project is part of the Environmental Protection Agency (EPA) Order no. VI-99-1221.

This amendment will provide additional compensation to the consulting engineering firm for construction phase services including inspection services due to the extended construction schedule.
