SUBJECT: Authorize the City Manager to negotiate and execute an agreement with Anderson Mill Municipal Utility District and Texas BLT, L.L.C. to provide temporary out-of-district domestic water and wastewater service by Anderson Mill Municipal Utility District for the "Sophie's Choice" tract located near the intersection of RM 620 and Anderson Mill Road.

AMOUNT & SOURCE OF FUNDING: No City funds are required by this action. Texas BLT, L.L.C. will construct all necessary water and wastewater infrastructure.

Anderson Mill Municipal Utility District (Anderson Mill MUD) is generally located along Hwy 183 and south of RM 620. Anderson Mill MUD has been a wholesale water and wastewater customer of the City of Austin since 1973 serving approximately 3,300 current connections.

Texas BLT, L.L.C. is planning to build a commercial development near the intersection of RM 620 and Anderson Mill Road on the "Sophie's Choice" tract (4.6 acres). Anderson Mill MUD's water and wastewater facilities are located within a hundred feet of the planned development. However, due to water capacity constraints the MUD's water facilities will only be able to provide domestic water service to the planned development. The nearest City of Austin water mains are located adjacent to the planned development but belong to a lower pressure zone that is required for this development for domestic water service. City of Austin water mains will be used for the provision of fire protection for the planned development. The nearest City of Austin wastewater mains are located 3,000 ft. from the planned development.

Texas BLT, L.L.C. has requested the City of Austin to provide out-of-district domestic water and wastewater service through Anderson Mill MUD facilities and would build all necessary facilities at its sole cost. Anderson Mill MUD has conceptually agreed to provide temporary out-of-district domestic water and wastewater service to the development until such time that the City of Austin has facilities that can be connected to the development.

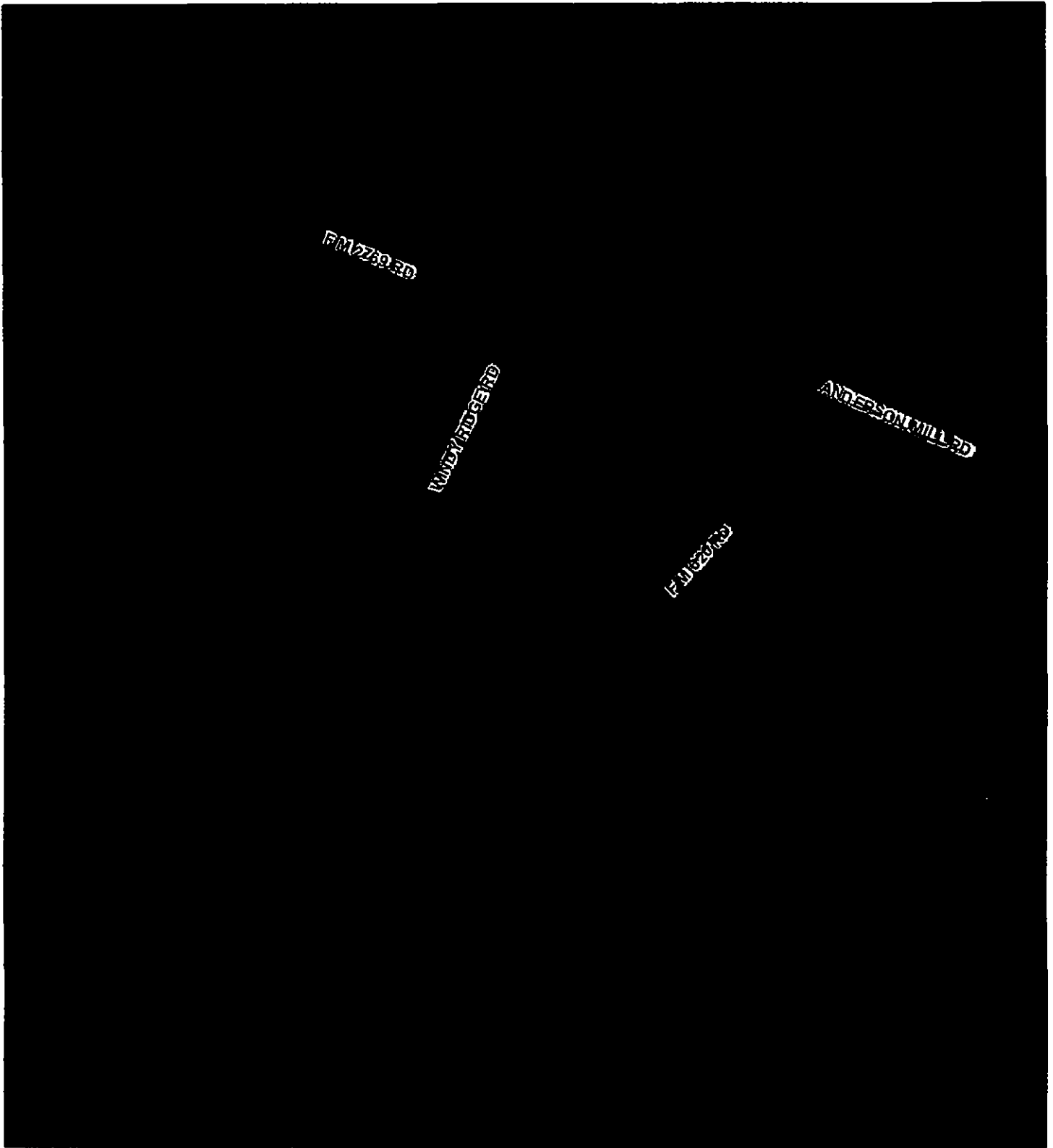
