SUBJECT: Authorize execution of a 12-month supply agreement with CUSTOM CRETE/CUSTOM STONE SUPPLY, Austin, TX, for the supply of ready mix concrete for the Austin Water Utility in an amount not to exceed \$67,053.20, with two 12-month extension options in an amount not to exceed \$67,053.20 per extension option, for a total agreement amount not to exceed \$201,159.60.

AMOUNT & SOURCE OF FUNDING: Funding in the amount of \$11,175.53 is available in the Fiscal Year 2003-2004 Approved Operating Budget of the Austin Water Utility. Funding for the remaining ten months of the original contract period and extension options is contingent upon available funding in future budgets.

**PURCHASING:** One bid received.

MBE / WBE: This contract will be awarded in compliance with Chapter 2-9 of the City Code (Minority-Owned and Women-Owned Business Enterprise Procurement Program). No subcontracting opportunities were identified; therefore, no goals were established for this solicitation.

This contract establishes an annual supply agreement with Custom Crete/Custom Stone Supply to provide ready mix for the Austin Water Utility. Ready mix is crucial to support the Austin Water Utility's work in the distribution and collection systems. Austin Water Utility uses ready mix concrete delivered to the projects for the thrust blocking of water line fittings, manhole foundations, backfill on protected streets, etc. Under this agreement the contractor will provide delivery of ready mix concrete Class A, Type J, and Controlled Low Strength Material (CLSM) Normal Set, Fast Set, and High Early Strength concrete. This contract allows Austin Water Utility to use a quality controlled concrete, meet construction standards and comply with street cut requirements in a timely manner.
