MBE / WBE: This contract will be awarded in compliance with Chapter 2-9 of the City Code (Minority-Owned and Women-Owned Business Enterprise Procurement Program). No subcontracting opportunities were identified; therefore, no goals were established for this solicitation.

Approval of this contract will provide for Phase II of the Austin Water Utility facilities' security project. This portion will include the furnishing and installation of an integrated access control system, closed circuit television system, and a traffic loop detector for egress from the three wastewater treatment facilities. A stand-alone closed circuit television monitoring system will be installed at the biosolids

Since September 11, 2001, the Austin Water Utility has undertaken a project to enhance security at its facilities to protect the water supply of the City, the Utility's assets, and its employees. The Austin Water Utility operates three wastewater treatment plants (WWTP) and one biosolids management facility (BMF). The four facilities are Govalle WWTP, Walnut Creek WWTP, South Austin Regional WWTP, and Hornsby Bend BMF. The three wastewater treatment plants can treat up to 120 million gallons of wastewater per day. Hornsby Bend BMF receives and processes approximately 80 dry tons of sludge per day from the three wastewater treatment plants. On November 20, 2003, Council approved a contract for Phase I to improve plant sites to ensure compliance with current regulatory access requirements of the City of Austin. The project consisted primarily of installation of perimeter fencing, gates and associated lighting. The work is now substantially complete.

Four security firms were pre-selected to participate in the bidding process. The pre-selection was necessary in order to limit the number of firms with access and knowledge of the locations for the security devices. Pre-selection of the security firms was made based upon the firms' qualifications, experience and prior contracts with the City. The firms selected were familiar with the systems to be installed and
