SUBJECT: Authorize execution of a 12-month service agreement with PIMPTON'S LANDSCAPING, INC. (MBE/MB-100%), Austin, TX, for landscape maintenance services at the former Robert Mueller Municipal Airport in an amount not to exceed \$118,000, with two 12-month extension options in an amount not to exceed \$118,000 per extension, for a total agreement amount not to exceed \$354,000.

AMOUNT & SOURCE OF FUNDING: Funding in the amount of \$19,667 is available in the Fiscal Year 2003-2004 Approved Operating Budget of the Finance and Administrative Services Department. Funding for the remaining 10-months of the original contract period and extension options is contingent upon available funding in future budgets.

Services for some sectors such as along fence lines that are visible to neighbors include mowing, weed-eating and trash pick-up twice monthly, while other interior areas not readily visible will be serviced quarterly. The annual amount spent for these services will be gradually reduced as areas of the airport property proceed with development.

The recommended contractor will provide all labor and equipment to perform these services.
