Austin Energy requests authorization to issue a letter of intent for a rebate in the amount of \$93,624, to Gayatri, Inc., for the installation of a solar photovoltaic system, in accordance with the City of Austin's Solar Rebate Program guidelines. The program is one element of Austin Energy's comprehensive Strategic Plan approved in December 2003.

Gayatri, Inc. is a 3,900 square foot convenience/specialty retail store located at 1950 South IH 35 in Austin, Texas. The solar photovoltaic equipment to be installed will provide a yearly energy savings of an estimated 26,000 kWh.

The City will not exceed the maximum incentive offer should the final installed measures be eligible for a higher rebate at the time of the inspection due to changes in quantity or efficiency of equipment.
