**SUBJECT:** Authorize execution of a 12-month supply agreement with INGRAM LIBRARY SERVICES, INC., La Vergne, TN, for the purchase of VHS and DVD videos in an amount not to exceed \$213,814.39, with two 12-month extension options in an amount not to exceed \$213,814.39 per extension option, for a total agreement amount not to exceed \$641,443.17.

AMOUNT & SOURCE OF FUNDING: Funding in the amount of \$17,818 is available in the Fiscal Year 2003-2004 Approved Operating Budget of the Library Department. Funding for the remaining 11-months of the original contract period and the extension options is contingent upon available funding in future budgets.

FISCAL NOTE: There is no unanticipated fiscal impact. A fiscal note is not required.
