This contract will provide for the construction of handicap-accessible sidewalks from the recreation center to the Capital Metro Bus Stop, located at the Mopac frontage road, concrete paving, handrails, retaining walls, accessible curb ramps, concrete underdrains, signage, concrete headwall and culvert pipe. The project is estimated to be completed in seventy-five (75) working days, weather permitting.
