These are two revenue contracts for the disposal of obsolete steel and steel products such as galvanized angles in various lengths and sizes, foundation cages and rebar, galvanized tubular steel transmission poles and arms, transmission tower cages and arms, galvanized steel light poles and arms, and used conductor wire. The cages and rebar are parts from poles that were used in different configurations and do not meet current performance requirements. The light poles and arms do not meet the current performance specifications or have been damaged through dismantling or by vehicle accidents. The used conductor wire was removed from the electrical system and replaced with a larger grade of conductor. The contractors will provide all services to complete the removal and disposal of these steel items which includes all material handling equipment, personnel and transportation.
