<u>SUBJECT:</u> Authorize negotiation and execution of a five-year revenue contract with KINSER RANCH L.L.C., Austin, TX, for golf course management at Butler Pitch and Putt Golf Course for an estimated revenue of \$66,000, with two five-year extension options with estimated revenue of \$72,000 for the first extension option and \$78,000 for the second extension option, for an estimated total revenue amount of \$216,000.

AMOUNT & SOURCE OF FUNDING: Estimated revenue of \$66,000 over the duration of the five-year contract period and \$72,000 and \$78,000 respectively, over the duration of each five-year extension option will be included in the Operating Budgets of the Parks and Recreation Department. Revenue is included in the Fiscal Year 2003-2004 Operating Budget of the Parks and Recreation Department.

FISCAL NOTE: There is no unanticipated fiscal impact. A fiscal note is not required.

BOARD AND COMMISSION ACTION: Recommended by the Parks and Recreation Board.

PURCHASING: One proposal received.

MBE / WBE: This contract will be awarded in compliance with Chapter 2-9 of the City Code (Minority-Owned and Women-Owned Business Enterprise Procurement Program). No subcontracting opportunities were identified; therefore, no goals were established for this solicitation.

This contract is for the management and operation of the golf course at the Butler Pitch and Putt Golf Course. Butler Pitch and Putt offers a par-three short irons golf course to participants of all ages and is one of the City's oldest concessions. The course is located in the Town Lake Corridor on the corner of Riverside Drive and Lee Barton Road. The contract value is based on the Concessionaire providing the

City \$1,100 per month of gross revenues for the first five years. The gross revenues will increase each

extension option.

The Kinser family has operated this golf course since 1951. Albert Winston Kinser, Jr. and Lee Hawley Kinser have a combined 40 years of experience in managing this golf course. They will manage the operations of the golf course including landscape maintenance, merchandise sales, and programming, which is designed to increase participation, by providing lessons and holding tournaments.

The contract value is based on the Concessionaire providing the City \$1,100 monthly for the initial five years. The Concessionaire will provide the City \$1,200 monthly for the first five-year extension option and \$1,300 monthly for the second five-year extension option. In addition, the Concessionaire will provide an additional 1% of annual gross sales up to \$80,000 and 1.5% of annual gross sales exceeding \$80,000.
