AN ORDINANCE AUTHORIZING FEES, FINES, AND OTHER CHARGES TO BE CHARGED BY CITY DEPARTMENTS FOR FISCAL YEAR 2004-2005 BEGINNING ON OCTOBER 1, 2004, AND ENDING ON SEPTEMBER 30, 2005.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

PART 1. The City Council authorizes the fees and fines listed in the attached Exhibit "A" to be charged by the various City departments for Fiscal Year 2004-2005 beginning on October 1, 2004, and ending on September 30, 2005.

PART 2. To the extent that a previous ordinance conflicts with this ordinance, the earlier ordinance is repealed.

PART 3. Except as otherwise specifically provided for an individual fee in Exhibit "A", this ordinance takes effect on October 1, 2004. A fee for which a specific effective date has been provided in Exhibit "A" takes effect on that specified effective date provided for that fee.
