Chapter 30 of the Texas Government Code requires that the Council appoint the Municipal Court Clerk by ordinance. Council appointed the Court Clerk and established her current compensation by adopting Ordinance No. 030227-65. This ordinance amends Ordinance No. 030227-65 to increase her compensation by 3.5%, from \$3,298.40 per pay period to \$3,413.60 per pay period, resulting in an annual salary of \$88,753.60. This ordinance is effective October 3, 2004, and the compensation increase will be reflected in the check received October 22, 2004. This action is consistent with Pay for Performance for non-civil service employees.
