SUBJECT: Authorize negotiation and execution of a professional services agreement with the following ten firms: MARTINEZ, WRIGHT & MENDEZ, INC., Austin, TX, (MBE/MH, 65%); URS CORPORATION, Austin, TX; HALFF ASSOCIATES, INC., Austin, TX; ALAN PLUMMER ASSOCIATES, INC., Austin, TX; EARTH TECH, INC., Austin, TX; KURKJIAN ENGINEERING CORPORATION, Austin, TX, (MBE/FH, 70.0%); RAYMOND CHAN & ASSOCIATES, INC., Austin, TX, (MBE/MA, 62.3%); HUNTER ASSOCIATES TEXAS LTD, Austin, TX; KLOTZ ASSOCIATES, INC., Austin, TX; and CLAUNCH & MILLER, INC., Austin, TX, for engineering services for the Americans with Disabilities Act (ADA) Sidewalk, Ramp and Bikeway Improvements Rotation List for a period of three years (3) or until financial authorization is expended, in an amount not to exceed \$5,000,000, with the total of the ten (10) agreements not to exceed \$5,000,000.

AMOUNT & SOURCE OF FUNDING: Funding in the amount of \$5,000,000 is available in the Fiscal Year 2004-2005 Capital Budget of the Public Works Department.

MBE / WBE: Participation goals stated in the solicitation were 15.9% MBE and 14.2% WBE.

In order to more effectively implement the ADA ramp, sidewalk, and bicycle program, staff has developed a new model to reduce the time and cost for design and construction of the projects. This Rotation List will allow for a team of experienced professionals to be readily available for design of the projects and to work directly with construction contractors to promptly address field engineering issues. The projects proposed for design under this initiative have been previously approved by one of the following methods: Council approval of proposed CMTA ¼ cent projects, Build Greater Austin projects, ADA Task Force projects, Child Safety program sidewalks, 1998 Bond funded Neighborhood sidewalks and Bicycle Plan projects.

The selected firms will perform the design of civil engineering projects consisting of sidewalks, ADA ramps, bikeways and associated work. The firms shall prepare detailed final design plans, specifications utilizing City of Austin standards, contract documents, cost estimates and permit support as needed for the construction of project improvements as approved by the City of Austin.

This request allows for the development of a professional service agreement with each of the ten (10) recommended firms for a period of three (3) years or until contracting authority is exhausted. Each of the

firms will be compensated under a standing contract for varying amounts depending on a rotation job assignment. It is intended that the value of the work assigned to each of the ten (10) selected firms be approximately equal (\$500,000 each) varying with the amount of work needed for each job assignment. Specific projects will be assigned on the basis of the firms' expertise and available resources. Reasonable effort will be made to distribute the work equally among the contracted firms. Should the City be unsuccessful in negotiating a satisfactory agreement with any one of the recommended prime firms, negotiations will cease with that firm and the funding will be distributed among the remaining firms.

Notification of issuance of a Request for Qualifications (RFQ) for the subject services was sent to two hundred-sixteen (216) firms on July 23, 2004. The RFQ was obtained by sixty-six (66) firms, and thirty-five (35) firms submitted qualification statements. Nine (9) of the firms were certified M/WBE firms. The evaluation of the submittals of the thirty-five (35) firms results in the following recommendation. Participation subgoals stated in the solicitation were 1.7% African-American, 9.5% Hispanic, 4.7% Asian-American, and 14.2% WBE. The recommended firms both provided M/WBE Compliance Plans, which were approved by the Department of Small and Minority Business Resources.
