<u>SUBJECT:</u> Authorize execution of a construction contract with MCLEAN CONSTRUCTION, LTD., Killeen, TX, for the Austin Clean Water Program Project: Moss, Rountree & Pannell Water and Wastewater Project in the amount of \$3,382,654 plus a \$338,265 contingency, for a total contract amount not to exceed \$3,720,919.

AMOUNT & SOURCE OF FUNDING: Funding in the amount of \$3,720,919 is included in the Fiscal Year 2004-2005 Capital Budget of the Austin Water Utility.

This construction contract will provide for wastewater and water improvements within a mostly residential area bounded by Manor Road, Boggy Creek, Martin Luther King Boulevard and Airport Boulevard. The majority of this project is part of the Austin Water Utility's Austin Clean Water Program (ACWP), which was developed to respond to the requirements of the Environmental Protection Agency's Administrative Order regarding Sanitary Sewer Overflows. The wastewater improvements will replace aging and deteriorated wastewater facilities and eliminate the repeat wastewater overflows currently occurring in this area. The water improvements will facilitate the elimination of repeat water maintenance issues and improvement of fire flows and water pressure in the area, which will assure safe and reliable drinking water and fire protection.

The proposed improvements include the installation of approximately 4,700 linear feet of wastewater line by open-cut and boring methods, 1,790 linear feet of water line to be installed by open-cut methods, 122 private laterals to be rerouted to the new collectors, and work in the critical water quality zone (Boggy Creek) to abandon the existing wastewater lines.

Due to the potential for unknown subsurface conditions and utility conflicts when working in the right-ofway, a 10% contingency in funding has been included to allow for the expeditious processing of any future change orders. The contract allows 260 working days for completion of this project.

Bid documents were distributed to 9 general contractors. Bids were opened on September 2, 2004. McLean Construction, Ltd. submitted the lowest of 4 bids received:


