As part of the Fiscal Year 2004-2005 Budget, City Council designated \$1,000,000 for the Holly Good Neighbor Program (HGNP). Austin Energy is requesting the City Council approve a resolution authorizing a variety programs in the Holly Street Neighborhood, including recreational and educational opportunities for children and neighborhood improvements in an amount not to exceed \$1,000,000. The recommended funding through the HGNP is summarized below:

- \$100,000 to the Austin Police Department (APD) to maintain a walking beat on East Cesar Chavez near Sanchez Elementary School and the Austin Baptist Chapel Soup Kitchen.
- \$30,000 to APD for maintenance of the "Reverse 911" emergency notification system in the Holly Neighborhood.
- \$300,000 to be transferred to the MACC/Terrazas Library O&M fund for operations and maintenance costs of the Mexican American Cultural Center and the Terrazas Branch Library. This allocation is the second in the series of four annual transfers.
- \$350,000 to the Neighborhood Housing and Community Development Department (NHCD) for rehabilitation of homes near the Holly Power Plant, and to assist local, community based CHDOs in developing, acquiring and/or rehabilitating quality affordable rental housing in the Holly Neighborhood.
- \$80,000 for the HOSTS program at Metz.

Proposed Amendment to Agenda Item No. B2 Use of Holly Good Neighbor Program Funds

The Holly Power Plant Subcommittee recommends that the above referenced agenda item be amended as follows:

- 1. Allocation of \$350,000 to NHCD. The uses of funds allocated to NHCD need to be broadened beyond strictly rehabilitation of homes. Once the Holly Power Plant closes consistent with the community's expressed desires, property value appreciation in the Holly neighborhood will increase sharply even more so than it currently has. This steep appreciation will exert significant displacement pressure on long-time Holly residents due to increased property taxes and higher rents. At its core, the Holly Mitigation Fund was intended to benefit long-time Holly residents. It would be a travesty if these same residents were unable to benefit from the considerable infrastructure investments that the program has already helped fund because they could no longer afford to live there. As a result, the subcommittee recommends that the funds allocated to NHCD be targeted more directly to support strategies that promote longer-term affordability and that NHCD be required to report back to Austin Energy and the EUC about the proposed allocation of these housing funds. Potential uses of funds could include:
 - a. Continued funding for rehabilitation of Holly neighborhood homes;
 - b. Grant monies to assist local, community based CHDOs in developing, acquiring, and/or rehabilitating quality affordable rental housing in the Holly neighborhood;
 - c. Grants and technical assistance to start a Holly neighborhood focused CHDO entity; and
 - d. Grant monies to pursue alternative strategies for ensuring that a portion of the housing in the Holly neighborhood remains affordable in perpetuity, such as investigating the feasibility of establishing a neighborhood community land trust
- 2. Undisbursed Funds from Other Program Allocations. If any portions of other allocated funds, such as the \$105,000 for other Good Neighbor Programs, are not spent, the subcommittee recommends that these funds be reallocated to NHCD consistent with the housing allocation discussed above.
