SUBJECT: Approve execution of a 12-month contract with FAMILY ELDERCARE, Austin, TX, to provide services that benefit low-income elderly Austin residents, in an amount not to exceed \$120,000, with two 12-month renewal options in an amount not to exceed \$120,000 per renewal option, for a total agreement amount not to exceed \$360,000.

AMOUNT & SOURCE OF FUNDING: Funding in the amount of \$120,000 is available in the Neighborhood Housing and Community Development (NHCD) Department Special Revenue Fund, the Community Development Block Grant (CDBG - 30th Year). The initial contract period will be October 1, 2004 – September 30, 2005. Funding for renewal options is contingent on performance and available funding in future budgets.

FISCAL NOTE: There is no unanticipated fiscal impact. A fiscal note is not required.

Background:

The City's 2005-2009 Consolidated Plan identified access to Senior Services as a high priority public service need.

The FAMILY ELDERCARE Senior Services Program is designed to provide services that benefit low-income elderly residents of Austin, with the ultimate goal of enhancing the quality of life for seniors in the Austin community. Senior Services funds are used to help prevent and protect elders from becoming victims of abuse, neglect, or exploitation, and enable them to live independently for as long as possible. Participating households income cannot exceed 80% of median income (\$56,900 for a family of four).

FAMILY ELDERCARE has provided services to seniors with CDBG funding for more than five years. The current contract ends September 30, 2004. The new contract recognizes FAMILY ELDERCARE as a CDBG sub-recipient agency, and continues the services that were designated as high priority in the Consolidated Plan.

Related Departmental Goal

Provision: Social Services – Promote and foster increased self-sufficiency, healthy behaviors, and lifestyle among targeted populations.

Outcomes

- 95% of In Home Care and Bill Payer clients served will be maintained in a safe environment where all basic needs are met (food, medical, housing, clothing) for three months following initiation of services.
- 85% of In Home Care and Bill Payer clients responding to surveys are satisfied with services provided (targeted response rate is 75% of Bill Payer clients served and 35% of In-Home Care Clients served).
- 95% of Bill Payer clients served in the program will have no new incident of abuse, neglect, or financial exploitation.
