SUBJECT: Authorize execution of a contract with MATCOR, INCORPORATED, Sugarland, TX, for consulting and inspection services for corrosion control on the fuel gas system at Decker Creek Power Station, in an amount not to exceed \$174,865.

PURCHASING: Lowest bid meeting specification of three bids received.

MBE / WBE: This contract will be awarded in compliance with Chapter 2-9 of the City Code (Minority-Owned and Women-Owned Business Enterprise Procurement Program). No subcontracting opportunities were identified; therefore, no goals were established for this solicitation.

This contract is for corrosion and integrity inspection services for the natural gas infrastructure supplying fuel gas to Decker Creek plant's two (2) steam units and four (4) gas turbines. At the conclusion of the inspection process a comprehensive five (5) year inspection plan will be developed allowing Austin Energy to plan and schedule maintenance on the natural gas piping. The maintenance plan will be prioritized with most urgent work occurring first ensuring the integrity and reliability of the system.

Consultation and inspection services are needed to ensure the safety and reliability of the fuel gas and oil lines that supply the two Decker boilers and the four gas turbines. Fuel oil is not a large safety hazard for the plant but does pose the threat of environmental exposure. The maintenance plan to be developed under this contract will help minimize the threat of such exposure.
